Reference to the complaint application submitted to the Interior Ministry on 17th January, 2019 having Diary Number 384/19-1M and previously to the ISIS relevant authorities/departments during the tenure of previous Government Cabinet as well.

I would like to extend findings about the 'Murder Attempts' from particular lobby mentioned in the previous referenced documentation with few more involved individuals information and their connected one(s) IDs. In this regard, Ghulam Bibi Bharwana MNA NA-115 Jhang involved with few more individuals connected with her from Toba Tekh Singh Faisalabad and the Arifwala, PakPattan regions. As per my findings, she is carrying multiple IDs for all these mess-ups and clearly connected with yours Ministry related attached security departments. Normally, they involved to cater Individual National personal data from these departments and to install biased professional Murder Attempters for the sake of their/her personal illegal benefits.

In this context, Imran Akram S/o Akram and others from Toba Tekh Singh having CNIC number, and carrying Mobile number 0300-6566338 and the Address N.No. 220, Muhalla Garden Town, Toba Tekh Singh and related to the Chak No. 338 from Toba Tekh Singh involved with her to establish multiple Murder Attempts during the one decade. In this regard, I have clear set of evidences against all these connected peoples which I can put onboard to yours Case-Handling (Investigation) team for their Decision Making approving authorities.

Further, few individuals with them involved and linked from Arifwala, Pak-Pattan region. These connected peoples heavily involved from/during one decade tenure to pull illegal-medication/drugs using self-based reasoning content to effect the mental health in this manner. Individuals connected with them having names M Obaidullah having CNIC 36401-4304441-9, resident of the Chal No. 67 EB, Daak Khanaa Arifwala, Tehseel Arifwala, Zilla Pak-Pattan and M Ilyaas having CNIC 36401-7531005-5, resident of the Chal No. 67 EB, Daak Khanaa Arifwala, Tehseel Arifwala, Zilla Pak-Pattan with Nabeela and the Meedo. Same way involved to plan and do Murder Attempts.

All this lobby heavily involved in the gambling/cheating of the Documentation related to Assets, Academia, Professional career and the personal liaison using Administration authorities/departments and the political umbrella. Few individuals relates to them living in House No. 36, Street No. 88, G-13/1, Islamabad having names Nadeem Abid, Naeem Aabid, Shaukat Ali and the M Mohsin. Abdul Majeed from I-14.

In this context, yours team also needs to evaluate their backing from serving Senator 'Faisal javed Khan' to protect their relevant crimes. Considering all the scenarios described in this documentation and the previously submitted documents. Yours Miinistry needs/requires to take appropriate steps for the Initial FIR against all these connected peoples including suffients content which covers all the matters in a proper way. As per my instructions, yours Misitry requires to address yours relevant Police Stations from Shah Jeevana Jhand, Chak No. 67 Arifwala PakPattan and 1-10 Sabzi Mandi Islamabad to stop these criminals in-future against such kind a below the belt crimes.

As per my findings, If Ghulam Bibi Bharwana MNA (NA-115) also serving in-yours departments with the ID Sidra D/o M Deen and involved to get Individual Nationals personal Data using administrative authorities and then to install Murder Attempters. Its necessary for yours Ministry and the relevant departments to take appropriate/strict official actions against all these connected one(s) for the future of the nation and safety of these security related departments. This mentioned particular lobby involved from more than one decade to establish self-based reasoning content and to acquire official resources for their personal benefits at large.

Further, I would to put yours Ministry attention towards killing/Murder of Fazal Din S/o Nizam Deen was carrying CNIC 61101-0792405-7 and resident from House No. 1113, Street No. 42, Sector I-10/2, Chambeli Road, Islamabad. He served in a Planning Commission Mistry department PIDE (Government of Pakistan) for more than 4 decades. Previously, clearly mentioned M Ilyaas CNIC 36401-4304441-9 and the permanent resident of Chak No. 67 EB, Daak Khaana Arifwala, Tehseel Arifwala, Zilla Pak-Pattan directly involved to kill Fazal Din. And he was heavily backed from Ghulam Bibi Bharwana MNA (NA-115) with others connected one(s) and the other way around, she carrying actual ID Sidra D/o M Deen and linked with Zeeshan-ulHassan Usmani. Most probably carrying actual ID with the name M Aqil Zeeshan S/0 M Deen and Dr. Rabeeh Ayaz Abbasi from QAU linked with them to impose Mental Dis-order on me using illegal drugs during 2012. At later stages or during that tenure, these peoples helped M Ilyaas and Imran Akram to moved outside Pakistan in a UAE and Saudia Arabia countries to stop and pull delay tactics in the Murder crimes. Mazhar S/o Liagat Ali from Arifwala PakPattan also linked and involved with them. They normally uses umbrella of Politician Ghulam Bibi Bharwana and the Senator Faisal Javed Khan. This is an Old habit from this particular lobby to protect Murderers and the the Attempters to provide protection umbrella using official authorities and to makes way arounds to move them outside Pakistan.

Same way around, this connected lobby killed M Abbass from Arifwala PakPattan region during 2015 for the sake of their personal benefits. He was from one of those persons, who opposing/blocking him for such kind a below the belt crimes.

In short, this particular lobby associated with you peoples security related departments and the different Government Cabinet tenures. On the other hand, clearly involved to establish self-based reasoning content using above mentioned sources and then involved to kill/murder individuals and to pull muder attempts on different individuals using official resources and to destroy their Business(s) in a different tenures. This thing requires at best to clean all these security related departments and the Government Cabinets from such kind a criminals carrying dual standards.
